
To be the choice for all who desire to create a Catholic Legacy in support of the mission of the Church within the Diocese of Venice and beyond.





THE PASSION AND VISION OF MARY FRAN CARROLL

Mary Fran Carroll was a woman of deep Catholic faith as well as a very successful business woman. Mary Fran retired as one of the first female executives with Northern Trust Co. in the late 1980s before serving as CEO of Schroeder-Manatee Ranch for more than a decade. In that role, she was responsible for much of the development of Lakewood Ranch. Mary Fran was also extremely devoted to her Parish, St. Martha Catholic Church in Sarasota, and to helping Catholic Charities in the Diocese of Venice.

Mary Fran dedicated her life to her faith, to fun and to charity. Her friend, as she called him, Bishop Frank Dewane, noted that, "Mary Fran embodied all these things in the way she lived. Through her incredible generosity, she wanted to make it possible for others to do the same things in their lives."

When Mary Fran passed away, she left a gift of \$3.6 million to the Catholic Community Foundation to establish an endowed scholarship fund to help others achieve career success through her Catholic legacy. She was committed to providing opportunities to those individuals willing to work hard to make a difference in the community and the Mary Fran Carroll Scholarship fulfills her dream to help both traditional and non-traditional students achieve success through education.

Ms. Carroll believed very strongly in the Catholic Church and in setting an example for others to follow; which is why she chose to create her scholarship with the Catholic Community Foundation. It was one of her hopes that other donors would follow her lead and create their own Catholic legacies in support of Catholic programs and services in the Diocese of Venice like she did.



TUITION ASSISTANCE FOR SPECIAL STUDENTS

St. Mary Academy in Sarasota is the only Catholic School in the Diocese of Venice dedicated solely to serving students with special learning needs. The school's mission is

> to "Develop a strong foundation of faith, values and knowledge for students with special learning needs while aspiring to challenge our students to achieve their individual potential."

Through endowment funds with the Catholic Community Foundation, donors provide critical tuition assistance for students like Alex, Michael

and Angie who otherwise would not be able to attend St. Mary Academy. The school's specialized programs, resources and spiritual formation have made a tremendous difference in each of their lives.

Alex, who is autistic, has made significant gains since attending the school. Michael was struggling severely in traditional classes, but since transferring to St. Mary Academy in second grade, has increased his reading level from complete non-reader to reading on grade level within one year. Angle is one of eight children, many of whom have disabilities. Her father passed away of a sudden heart attack and her mother works very hard to support all of them. Without tuition assistance from Catholic Community Foundation donors, Angie and her siblings would not be able to receive the Catholic education and support they need from St. Mary Academy.

THE CATHOLIC LEGACY OF DR. SERGIO CRUZ


Dr. Sergio Cruz was very unassuming, kind and generous with his time, talent and treasure. He was also extremely passionate about his Catholic faith and the importance of a Catholic education. Dr. Cruz wanted to make a difference in people's lives, especially for those in need. He even travelled every year to Peru on mission trips to help the most vulnerable both physically and spiritually.


Dr. Cruz wanted to leave a significant legacy in support of Catholic education in the Diocese of Venice. By working with the Catholic Community Foundation, he was able to leverage his resources in order to create a substantial endowment fund in memory of his mother. The Consuelo Cruz Scholarship Fund provides tuition assistance for Hispanic children who want to attend Catholic School in Charlotte County Florida, but do not have the family resources to do so.

By utilizing a number of planned giving strategies, Dr. Cruz contributed a total of \$465,000, but was able to establish a \$1.2 million endowment fund, which will pay out approximately \$48,000 every year in perpetuity in fulfillment of his wishes.

The diagram below illustrates how Dr. Cruz was able to achieve his goal:

- **Step 1**: Dr. Cruz established three Charitable Gift Annuities with \$411,000 in stock. He received an immediate \$99,000 tax deduction and did not have to pay capital gains tax on the stock transfer.
- Step 2: Dr. Cruz received \$26,000 per year in payments from the Gift Annuities for the remainder of his life. Most of this income was considered tax free.
- Step 3: Dr. Cruz opened a life insurance policy and made the Catholic Community Foundation the owner of the policy (which made the Foundation responsible for the annual insurance premium). He then donated \$35,000 per year to the Foundation, which was fully tax deductible. Dr. Cruz used the \$26,000 from the Gift Annuities to pay for most of this payment.
- Step 4: The Foundation paid the \$35,000 annual insurance premium.
- **Step 5**: When Dr. Cruz passed away, the \$900,000 from the life insurance policy and the \$300,000 remainder from the Gift Annuities were used to establish the \$1.2 million endowment fund.
- **Step 6**: 4% of the value of the endowment fund is distributed every year for Catholic education.





All endowment and scholarship funds are the property of the Catholic Community Foundation held in its corporate capacity and shall not be deemed a trust held in a trustee capacity. Distributions from all funds can only be used in alignment with donor restrictions.





FINANCIAL DISCLOSURES

The Catholic Community Foundation of Southwest Florida (the Foundation) was incorporated in 2002 under the laws of the State of Florida and is considered a tax exempt, charitable organization under section 501(c)(3) of the Internal Revenue Code.

ACCOUNTING POLICIES

The financial statements of the Foundation are prepared on the accrual basis of accounting and, accordingly, reflect all significant revenues, expenses, assets, liabilities and net assets of the Foundation. Annually, the financial statements are audited by an independent outside CPA firm.

INVESTMENT POOL

The Foundation utilizes common investment pools to manage most of its investments. The earnings from investments (interest and dividends) as well as investment gains and losses of the pools are allocated to the individual fund according to its percentage of the total investment pool.

DISTRIBUTION POLICY

The policy is reviewed annually by the Board of Directors. The Foundation's current distribution policy is to distribute up to 4% of a fund's average market value over the previous 12 rolling quarters.

CHARITABLE GIFT ANNUITIES

The Foundation administers various charitable annuity and remainder trust agreements with donors. The arrangements provide for agreed upon distributions over a designated period of time (usually the designated beneficiary's lifetime or a term of years). A liability has been recorded equal to the present value of the estimated future obligation. This obligation amount includes the present value of all anticipated payments to the donors based on their life expectancy or a term of years. The Foundation revalues this liability annually.
